
Engineer's Welcome


2020 Revenue & Expenses

The majority of the Scioto County Engineer's revenue comes from the motor vehicle gas tax and the motor vehicle license tax. These taxes are collected and distributed by the State. Additional revenue comes in the form of various grants. Grant funds come from several sources and are normally used for specific projects.

It is the goal of our office to maintain a budget carryover (for revenues to exceed expenses). Carryover funds are used in later years for matching grant funds, emergencies, etc.



2020 Rebuilt/Refurbished Equipment by County Forces



The photo above displays the single-axle and tandem-axle trucks purchased by the county in 2020.

The two tandem-axle trucks (far right, 2nd from right) were converted from flatbed trucks to dump trucks and painted by County Engineer forces. The estimated cost for two new tandem-axle dump trucks is \$240,000. The total purchase amount paid for the tandem-axle trucks was \$54.815.

The three single-axle trucks (far left, 2nd from left, 3rd from left) were purchased as surplus equipment. The single-axle trucks were refurbished and painted by County Engineer forces. The estimated cost for three new single-axle dump trucks is \$420,000. The total purchase amount paid for the single-axle trucks was \$18,448.75.






